## ECE-520: Discrete-Time Control Systems Homework 8

Due: Monday February 8

In this homework we will simulate and study minimum order observers coupled with state variable feedback, and then we will add on integral control.

Minimum order observers only estimate those states we don't know or can't measure. If a state is know, the minimum order observer uses that state.

For the first four problems, utilize the continuous time torsional system models available from the class website (the same models as we used for homework 7).

1a) Copy your program **DT\_sv1\_observer\_driver.m** to **DT\_sv1\_min\_obs\_driver.m** You will need to modify the part of the code that determines the observer gains, and you will have to have the program call the simulation **DT\_sv1\_min\_observer.mdl**. Copy the Simulink file **DT\_sv1\_observer.mdl** to **DT\_sv1\_min\_observer.mdl**. Modify this <u>new</u> file to implement state variable feedback using a minimum order observer to estimate the states for a one degree of freedom system. In addition, you will need to modify your code so that you can utilize different sampling rates.

Assume we want the state vector written as  $\begin{bmatrix} x & u_d & \dot{x} \end{bmatrix}^T$ . You need to modify both G and H to reflect this new ordering. You also need to fix the demuxes in your Simulink file to reflect this new order.




Figure 1. Results for problem 1b.

- b) Assume the only known state is the position, and the output is the position of the disk. Use a sampling interval of 0.05 seconds, assume all the state feedback poles are at 0.5, and the observer poles are at 0.2 and 0.3. Also assume the system initially starts at a position of 10 degrees, with an initial velocity of 10 degrees, and an initial delayed input of 10 degrees (be careful of units here! The model works in radians.). The initial estimates of the observer are zero. For a 10 degree step input you should get the graph shown in Figure 1. Turn in your plot.




Figure 2. Results for problem 1c.

- c) Now assume the same initial conditions as in part a, but both the position of the disk and the delayed input signal are known. The observer pole is placed at 0.3 and the sampling interval is still at 0.05. For a 10 degree step input you should get the graph shown in Figure 2. Turn in your plot.




Figure 3. Results for problem 1d.

- d) Now assume the same conditions as **c**, but with a sampling interval of 0.03 seconds. For a 10 degree step input you should get the graph shown in Figure 3. Turn in your plot.

- 2) Now we want to combine the minimum observer and state feedback with integral control for the one degree of freedom system.
- a) Create a driver file **DT\_sv1\_min\_obs\_servo\_driver.m** and a corresponding Simulink file **DT\_sv1\_min\_obs\_servo.mdl.** Modify this <u>new</u> file to implement state variable feedback using a minimum order observer to estimate the states for a one degree of freedom system. In addition, you will need to modify your code so that you can utilize different sampling rates. Assume we want the state vector written as  $\begin{bmatrix} x & u_d & \dot{x} \end{bmatrix}^T$ . You need to modify both G and H to reflect this new ordering. You also need to fix the demuxes in your Simulink file to reflect this new order.




Figure 4. Results for problem 2b.

- b) Assume the only known state is the position, and the output is the position of the disk. Use a sampling interval of 0.05 seconds, assume all the state feedback poles are at 0.5, and the observer poles are at 0.2 and 0.3. Also assume the system initially starts at a position of 10 degrees, with an initial velocity of 10 degrees, and an initial delayed input of 10 degrees (be careful of units here! The model works in radians.). The initial estimates of the observer are zero. For a 10 degree step input you should get the graph shown in Figure 4. Turn in your plot.




Figure 5. Results for problem 2c.




Figure 6. Results for problem 2d.

- c) Now assume the same initial conditions as in part **b**, but both the position of the disk and the delayed input signal are known. The observer pole is placed at 0.3 and the sampling interval is still at 0.05. For a 10 degree step input you should get the graph shown in Figure 5. Turn in your plot.

d) Now assume the same conditions as part  $\mathbf{c}$ , but with a sampling interval of 0.03 seconds, For a 10 degree step input you should get the graph shown in Figure 6. Turn in your plot.

3) Copy your program **DT\_sv2\_observer\_driver.m** to **DT\_sv2\_min\_obs\_driver.m** You will need to modify the part of the code that determines the observer gains, and you will have to have the program call the simulation **DT\_sv2\_min\_observer.mdl**. Copy the Simulink file **DT\_sv2\_observer.mdl** to **DT\_sv2\_min\_observer.mdl**. Modify this *new* file to implement state variable feedback using a minimum order observer to estimate the states for a one degree of freedom system. In addition, you will need to modify your code so that you can utilize different sampling rates.

Assume we want the state vector written as  $\begin{bmatrix} x_2 & x_1 & \dot{x}_1 & \dot{x}_2 & u_d \end{bmatrix}^T$ . You need to modify both G and H to reflect this new ordering. You also need to fix the demuxes in your Simulink file to reflect this new order.

You also need to modify the **get\_desired\_states** variable as follows so the ECP system will put your states in this order:

get\_desired\_states = [0\ 0\ 1\ 0\ 0\ 0\ 0\ 0;\\ 1\ 0\ 0\ 0\ 0\ 0\ 0;\\ 0\ 1\ 0\ 0\ 0\ 0\ 0;\\ 0\ 0\ 0\ 1\ 0\ 0\ 0\ 0];




Figure 7. Results for problem **3b**.

```

b) Assume the only known state is the position of the second disk, and the output is the position of the first disk. Use a sampling interval of 0.05 seconds, assume all the state feedback poles are at 0.5, and the observer poles are at [0.01 0.015 0.02 0.025]. Also assume the system initially starts with disk 2 at zero degrees, disk 1 at 5 degrees, and both disks with an initial velocity of 5 degrees/sec (be careful of units here! The model works in radians.). The initial estimate of the delayed input signal is zero. The initial estimates of the observer are zero. For a 10 degree step input you should get the graph shown in Figure 7. Turn in your plot.




Figure 8. Results for problem 3c.

- c) Same conditions as in **b**, but assume the output is the position of the second disk. For a 10 degree step input you should get the graph shown in Figure 8. Turn in your plot.




Figure 9. Results for problem **3d**.

- d) Same conditions as **b**, but now the positions of both disk 1 and disk 2 are known (the output is the position of the first disk). Place the state feedback poles all at 0.2 and the observer poles at [0.01 0.015 0.02]. For a 10 degree step input you should get the graph shown in Figure 9. Turn in your plot.




Figure 10. Results for problem **3e**.

- e) Same conditions as **d**, but the sampling interval is now 0.035. For a 10 degree step input you should get the graph shown in Figure 10. Turn in your plot

4) Now we want to combine the minimum observer and state feedback with integral control for the two degree of freedom system. Create a driver file **DT\_sv2\_min\_obs\_servo\_driver.m** and a corresponding Simulink file **DT\_sv2\_min\_obs\_servo.mdl.** Modify this *new* file to implement state variable feedback using a minimum order observer to estimate the states for a two degree of freedom system. In addition, you will need to modify your code so that you can utilize different sampling rates.

Assume we want the state vector written as  $\begin{bmatrix} x_2 & x_1 & \dot{x}_1 & \dot{x}_2 & u_d \end{bmatrix}^T$ . You need to modify both G and H to reflect this new ordering. You also need to fix the demuxes in your Simulink file to reflect this new order.

You also need to modify the **get\_desired\_states** variable as follows so the ECP system will put your states in this order:

get\_desired\_states = [0\ 0\ 1\ 0\ 0\ 0\ 0\ 0;\\ 1\ 0\ 0\ 0\ 0\ 0\ 0;\\ 0\ 1\ 0\ 0\ 0\ 0\ 0;\\ 0\ 0\ 0\ 1\ 0\ 0\ 0\ 0];




Figure 11. Results for problem 4b.

```

b) Assume the only known state is the position of the second disk, and the output is the position of the first disk. Use a sampling interval of 0.05 seconds, assume all the state feedback poles are at 0.5, and the observer poles are at [0.01 0.015 0.02 0.025]. Also assume the system initially starts with disk 2 at zero degrees, disk 1 at 5 degrees, and both disks with an initial velocity of 5 degrees/sec (be careful of units here! The model works in radians.). The initial

delayed input is assumed to be 0. The initial estimates of the observer are zero. For a 10 degree step input you should get the graph shown in Figure 11. Turn in your plot.




Figure 12. Results for problem 4c.

- c) Same conditions as in **b**, but assume the output is the position of the second disk. For a 10 degree step input you should get the graph shown in Figure 12. Turn in your plot.
- d) Same conditions as **b**, but now the positions of both disk 1 and disk 2 are known (the output is the position of the first disk). Place the state feedback poles all at 0.2 and the observer poles at [0.01 0.015 0.02]. For a 10 degree step input you should get the graph shown in Figure 9. Turn in your plot.
- e) Same conditions as **d**, but the sampling interval is now 0.04. For a 10 degree step input you should get the graph shown in Figure 10. Turn in your plot




Figure 13. Results for problem 4d.




Figure 14. Results for problem 4e.

## Preparation for Lab

5) You should load your <u>continuous time models</u> (from labs 1 and 2) into your Matlab driver files so you will be able to try sampling at different rates. You only need to simulate the torsional systems (or only the rectilinear systems). You can change the sampling interval if it helps you get better responses, but don't use a sampling interval smaller than 0.02 seconds. Assume both your system and the observer states are all zero at the beginning of the simulation. (You will most likely not be able to see any difference between the estimated and true states.) Your system should meet the following contstraints:

For a 10 degree step input:

- the settling time for your system is less than 1 s
- the percent overshoot for your system is less than 20%
- the control effort does not hit a limiter (does not saturate)
- the steady state error is zero
- a) For your one degree of freedom model, utilizing state variable feedback and a *minimum* order observer (no integral control). Assume the position of the disk is available to the observer.
- b) For your one degree of freedom model, utilizing state variable feedback, a *minimum* order observer, and integral control. Assume the position of the disk is available to the observer.
- c) For your two degree of freedom model, utilizing state variable feedback and a *minimum* order observer (no integral control). Assume the positions of both disks are available to the observer, and you want to control the position of the first disk.
- d) For your two degree of freedom model, utilizing state variable feedback, a *minimum* order observer, and integral control. Assume the positions of both disks are available to the observer, and you want to control the position of the second disk.

Turn in all four plots, as well as a copy of the Simulink model for part **d** and the Matlab code for part **d**.
